However, without the PHCB report, the Thromde changed the Success Indicator "Percentage of awareness and knowledge of segregation and 3 Rs among Thromde residents" to "Number of awareness and knowledge of segregation and 3 Rs among Thromde residents" targeting "5 numbers while signing the APA between the Executive Secretary and the Division Heads on 18th August 2017.	Request to change the Success Indicator to "Number of awareness and knowledge of segregation and 3Rs among Thromde residents (Target: 5)"
